Strategic Transportation Investments (STI) Law

- Passed into law by the NC General Assembly in 2013: Chapter 136, Article 14B
- Establishes the Strategic Mobility Formula (which replaces the equity formula used in P1.0 and P2.0).
- Prioritizes capital expenditures across all modes (Mobility/Expansion + Modernization)
- Needs-based, data driven
- Directly ties funding to Prioritization results
- Funding comes from the Highway Trust Fund and Federal Aid Program
- Workgroup used every cycle for improving the prioritization process





 - Funding Categories and Percentages
 - Project Eligibility
 - Highway Scoring Criteria Names
 - Funding Constraints
- The Workgroup recommends and BOT approves:

 - Highway Measures and Weights
 - · Non-Highway Criteria, Measures, and Weights
 - Modal Allocation (funding allocation between modes)
 - Local Input Points




Project Eligibility: Highway – Statewide Mobility




Project Eligibility: Highway – Regional Impact




Project Eligibility: Highway – Division Needs



Project Eligibility: Aviation – All Categories




Project Eligibility: Rail – Statewide Mobility






Prioritization 8.0 North of the Albemarle Bike/Ped Projects



Prioritization 8.0 North of the Albemarle Highway Projects










Prioritization 8.0 South of the Albemarle Bike/Ped Projects

Summary of Information:

Functional classification is a federally defined process by which streets and highways (roadways) are grouped into classes according to the character of service they are intended to provide. These classes are as follows: 1 – Interstate, 2 – Other Freeways & Expressways, 3 – Other Principal Arterial, 4 – Minor Arterial, 5 – Major Collector, 6 – Minor Collector, and 7 – Local.

Following every decennial census, each state DOT must review its functional classification network for potential changes. To facilitate the statewide review for North Carolina, NCDOT directed RPOs and MPOs to review the functional classification networks within their respective boundaries, and to identify any potential changes. In June 2025, staff submitted a draft list of functional classification change requests for the Albemarle RPO to NCDOT. Following this, the statewide Functional Classification System Revision Committee reviewed the proposed changes, and provided feedback to RPO staff in July 2025. RPO staff then worked with the NCDOT Transportation Planning Division to incorporate this feedback into the proposed list of functional classification changes.

RPO staff will present the proposed functional classification changes for the Albemarle RPO region. If approved by the RTCC and RTAC, the proposed changes will be sent to the NCDOT Transportation Planning Division. The Functional Classification System Revision Committee will then decide whether or not to recommend approval of the proposed changes to the Federal Highway Administration (FHWA).



Roadway Functional Classification Overview

1	Interstate	Roadways are officially designated as Interstates by the USDOT Secretary of Transportation
2	Other Freeways & Expressways	Access and egress points are limited to on- and off-ramp locations or limited number of at-grade intersections; typically have directional travel lanes separated by some type of physical barrier
3	Other Principal Arterial	Serve major centers of metropolitan areas; provide a high degree of mobility and can also provide mobility through rural areas; can serve abutting land uses directly
4	Minor Arterial	Provide service for trips of moderate length; Serve geographic areas that are smaller than their higher arterial counterparts; offer connectivity to the higher Arterial system
5	Major Collector	Serve primarily intra-county travel (rather than statewide); gather traffic from Local Roads and funnel to the arterial network; offer more mobility (while minor collectors offer more access); when compared to minor collectors, are longer in length, have higher speed limits and may have more travel lanes
6	Minor Collector	Offer more access (while Major Collectors offer more mobility); gather traffic from Local Roads and onto the arterial network; when compared to major collectors, have lower speed limits, are spaced at shorter intervals and have lower traffic volumes; in rural areas, AADT and spacing may be the most significant designation factors



Please accept this letter of support for the North Carolina Department of Transportation (NCDOT) Ferry Division's application to the USDOT's FY27-29 Eastern Federal Lands Access Program (FLAP) grant program. This Project will work towards reliable, long-term access to the Cape Hatteras National Seashore (CAHA) and support Ocracoke Island's tourism industry, a mainstay of the local economy, by studying the feasibility of implementing passenger ferry service between mainland ferry terminals at Swan Quarter and Cedar Island and Ocracoke Village at Silver Lake.

We understand that NCDOT faces significant challenges to secure safe and reliable long-term access to Ocracoke Island. Key among them are storm damage and erosion that cause continual damage and closures affecting the Hatteras to Ocracoke vehicle ferry service and NC 12 on Ocracoke Island. Adding additional passenger ferry service would improve access for day-trippers and tourists to CAHA, which received over 2.8 million visitors in 2024. Currently, park visitors and tourists must endure longer-than-desired wait times for vehicle ferry service during the peak season, and passenger ferry service from Hatteras Island has proved a popular alternative.

The feasibility study will include public engagement, ridership projections, pedestrian mobility improvements, conceptual design, and study various vessel and operational approaches for future passenger ferry service. These elements are foundational to developing an implementation plan and securing funding for this project.

We support NCDOT's efforts to study the potential for new and expanded passenger ferry service and believe it will promote access to a significant Federal recreation resource, strengthen the region's transportation system, and support the economy of Ocracoke Island. We strongly encourage you to favorable consider the NCDOT Ferry Division's project for Eastern FLAP funding.

The Albemarle Rural Planning Organization (ARPO) supports the North Carolina Department of Transportation's (NCDOT) application for the FY 2027-2029 Federal Lands Access Program (FLAP) Grant. The project will improve pedestrian access to multiple federal lands along the Outer Banks of North Carolina by constructing pedestrian crossing improvements at 15 locations along NC 12 and US 158, including 11 locations with an existing crossing and four locations that do not have an existing crossing. Proposed treatments for the locations include Americans with Disabilities Act (ADA) compliant curb ramps, high-visibility crosswalks, signage and Rectangular Rapid Flashing Beacons (RRFB). The improvements would introduce dedicated, safe crossings at several new locations and would also enhance existing crossings, helping to prevent accidents and injuries along this heavily traveled route.

The Albemarle Rural Planning Organization (ARPO) represents ten counties across northeastern North Carolina: Camden, Chowan, Currituck, Dare, Gates, Hyde, Pasquotank, Perquimans, Tyrrell, and Washington. Rural Planning Organizations were established to ensure that rural county and municipal governments have a meaningful voice in transportation planning and decision-making. Utilizing the FLAP Grant for this project would directly enhance connectivity and fix long standing safety problems within some of the most heavily traveled and tourism-driven areas of the ARPO region, supporting both local mobility and regional economic development.

The crossing improvements will provide improved access to popular destinations, helping residents and visitors safely access locations that are integral to the economic sustainability of the region and are visited by millions of people each year. The project aligns with FLAP's vision to enhance visitor mobility and accessibility to natural and cultural resources that drive tourism on the Outer Banks and contribute greatly to the economic development of the area.

Camden Currituck Pasquotank Regional CTP - First Steering Committee Meeting Update

The first Steering Committee meeting was held on June 16, 2025. Key items included:

- **Plan Overview** Reviewed the purpose and schedule of the CTP, which will guide long-range multimodal needs through 2027.
- Resilience Study Introduced focus on flooding, sea level rise, and other risks, with tools available to support emergency response and funding.
- Community Understanding Report (CUR) Shared draft covering demographics, land use, transportation conditions, and community concerns for committee review.
- Map Exercise Updated study road network by identifying missing connections, needed removals, and segments vulnerable to natural hazards.

Action Items:

- Review and provide feedback on the draft Community Understanding Report.
- Revise study road maps based on committee comments.
- Develop draft Vision, Goals, and Objectives for discussion.
- Prepare land use plan review and public survey for next meeting.
- Identify additional committee representatives to broaden participation.

Next steps include distributing revised study road maps, gathering comments on the draft Community Understanding Report, and preparing draft Vision, Goals, and Objectives for discussion. The second Steering Committee meeting, scheduled for late summer, will also include review of land use plans and draft public outreach materials, including a survey. Committee members were asked to help identify additional representatives to ensure broad and inclusive participation.

This first meeting provided a strong start to the regional plan, setting the stage for collaborative work ahead to build a resilient and multimodal transportation framework for Camden, Currituck, and Pasquotank Counties.

Albemarle RPO Receives 15 Project Submittal Units for P8 Funding Cycle

As part of North Carolina's ongoing Prioritization 8.0 (P8) process, the Albemarle Rural Planning Organization (RPO) has been allocated 15 project submittal units for the 2025 funding cycle. This allocation was confirmed in the May 1, 2025 meeting of the NCDOT Board of Transportation and reflects the region's authorized capacity to nominate federally supported transportation projects under the Strategic Transportation Investments (STI) law.

This allocation is critical for advancing regional transportation priorities and enables the Albemarle RPO to submit up to 15 candidate projects for potential inclusion in the State Transportation Improvement Program (STIP).

These projects may be eligible for funding from a range of federal sources, including: STBG (Surface Transportation Block Grant), TA (Transportation Alternatives), HSIP (Highway Safety Improvement Program), and CMAQ (Congestion Mitigation and Air Quality Program), as well as FTA programs for rural and regional transit investments.

The Albemarle RPO's submittal capacity is determined by NCDOT based on population, local infrastructure needs, and project readiness, ensuring an equitable approach to statewide transportation planning.

Camden Currituck Pasquotank Regional CTP - Second Steering Committee Meeting Update

The second Steering Committee meeting for the Camden–Currituck–Pasquotank (CCP) Regional Comprehensive Transportation Plan was held on September 4, 2025, at the Dismal Swamp State Park Visitor Center with both in-person and virtual participation.

Key Updates and Decisions:

- The official project title was confirmed as Camden, Currituck, and Pasquotank Regional CTP to avoid confusion with the broader Albemarle RPO region.
- The study roadway network was expanded to include 23 additional routes, mainly minor thoroughfares, with a revised GIS database prepared for distribution.
- Local land use and transportation plans were confirmed for integration, including recent comprehensive and pedestrian plans; members were asked to share any additional or in-progress plans.
- A revised Community Understanding Report (CUR) was distributed, with comments from members to be incorporated.
- Draft Vision, Goals, and Objectives (VGO) were presented, focusing on safety, resilience, accessibility, and sustainable growth. Members were invited to provide final comments by September 10 to align with the public survey.

Public Engagement:

- A PublicInput survey will be launched <u>September 15 and remain open through October 31</u>. It will be available in English and Spanish, with paper copies distributed at senior centers, libraries, county offices, and community events.
- Flyers with QR codes will be circulated, and committee members will assist with outreach.
- Upcoming events identified for survey promotion include the Camden Heritage Festival (Sept. 20), Currituck's "Plains and Paws for Corridor" event (Oct. 11), and the Elizabeth City Craftsman's Fair (Oct. 24).

Next Steps:

- Publish and promote the survey from September 15 to October 31.
- Continue review of the Community Understanding Report and Vision, Goals, and Objectives.
- Prepare roadway capacity analysis and draft mode-specific maps (public transit/rail, bicycle, pedestrian).
- Schedule the next Steering Committee meeting for late November or early December to review survey results.
- Offer one-on-one local briefings to support awareness and participation ahead of adoption.

This meeting built on the momentum of the first session by finalizing the project name, refining study roads, advancing the Community Understanding Report, and preparing for the fall public survey.

Albemarle RPO Functional Classification (FC) Review Update

The Albemarle RPO has submitted a request to revise the classification of 21 roadway segments as part of NCDOT's statewide FC Review. This effort ensures the roadway network remains accurate and consistent with FHWA requirements for planning, funding, and system performance.

- Proposed changes were developed in coordination with NCDOT's Transportation Planning Division.
- Final FC update requests from ARPO and TPD staff were delivered to the FC Review Committee on August 29, 2025.
- NCDOT and the committee are reviewing the proposals, with FHWA final approval expected by the end of the year. A map and table of the proposed changes are included in the attached PDF.

FY 2025-2026 Planning Work Program (PWP) Adopted

FY 2025–2026 Planning Work Program (PWP) Adopted On April 23, 2025, ARPO's RTCC and RTAC adopted the Fiscal Year 2025–2026 Planning Work Program, which takes effect on July 1, 2025.

The total allocation of **\$183,500** is distributed as: 80% from Federal SPR funds (\$146,800), 15% from State Local Match Assistance (\$27,525), 5% from local county match (\$9,175).

This program lays out ARPO's planning priorities, including data collection, regional CTP development, and engagement in the Prioritization 8.0 nomination process. It provides the framework for regional transportation planning through June 30, 2026.

Purpose:

The Strategic Prioritization Process is designed to determine which projects should be selected for funding using a combination of data and local input. This evaluation occurs while many projects are still in a conceptual phase and have had limited engineering review. To help minimize issues once projects are selected for funding, it is critical to make sure that projects submitted for evaluation have had an engineering analysis performed to make sure it is feasible to construct them and have accurate cost estimates. Refined cost estimates are crucial in the Prioritization and Programming processes. In Prioritization, project costs are evaluated as part of a project's quantitative score. Ensuring that project costs are developed using a consistent minimum standard allows for a level playing field when comparing projects to each other. The Programming process relies heavily on the cost estimates submitted in Prioritization when developing the State Transportation Improvement Program (STIP). As a fiscally constrained document, the STIP outlines which projects will be constructed or start project development over the next 10 years. Underdeveloped cost estimates, which typically are much lower than actual project costs, require the STIP to be rebalanced when costs are updated. This rebalancing can ultimately lead to other projects being delayed or paused to maintain the fiscally constrained STIP. With stronger cost estimates at the time of Prioritization submittal, there is an opportunity to relieve this issue. Express Designs, which review project concepts in detail prior to the Preliminary Engineering phase of a project, are a helpful way to develop more-refined cost estimates using a consistent standard. This requirement will verify the feasibility of projects based on cost, concept, and scope prior to submittal.

Requirement:

All Highway projects submitted in P9 or later will require an Express Design level estimate or greater:

- Cost Verification Memos (CVMs), which are developed by NCDOT once a project has reached a
 higher level of Preliminary Engineering in the project development phase, are greater and will
 suffice for this requirement if available.
- SPOT Online Cost Estimation Tool (CET) estimates will not suffice. The Cost Estimation Tool is a
 feature in SPOT Online that will generate a cost for a project using standard unit costs for
 specific project types based on NCDOT's recent letting costs.
- This requirement does not apply to Non-Highway projects for P9.


A single Express Design may be used for multiple Prioritization submittals, under the following conditions:

- The Express Design study area completely covers the area for the projects being submitted; <u>and</u>
- The cost developed in the Express Design is sufficiently modularized (i.e. separated out in sections) to obtain an accurate cost for each submittal



Multiple versions of the same project would likely require multiple Express Designs:

- Express Designs generally develop costs for a single alternative
 - Feasibility Studies Unit (FSU) Express Designs will include no more than 2 alternatives
- Multiple alternatives of the same project would therefore likely not be covered by a single express design
- To submit multiple versions of a project in Prioritization, multiple Express Designs may need to be used



Exceptions:

Projects would be exempt from an Express Design requirement by meeting <u>both</u> of the following conditions:

- 1) Cost Estimation Tool (CET) cost of less than \$10M generated during the submittal window for the cycle it is being submitted, **and**;
- 2)Being one of the following Prioritization Specific Improvement Types (SITs):
 - SIT 10 Improve Intersection (including a roundabout)
 - SIT 12 Ramp Metering
 - SIT 13 Citywide Signal System
 - SIT 14 Closed Loop Signal System
 - SIT 15 Install Cameras and DMS
 - SIT 19 Improve intersection on Local (Non-state) Roadway
 - SIT 21 Realign Multiple Intersections
 - SIT 22 Construct Auxiliary Lanes or Other Operational Improvements
 - SIT 25 Improve Multiple Intersections along a Corridor



If an organization would like an Express Design for a project that meet this criteria, it can still be requested; however, it will count towards their allotted Express Designs.

Each organization (MPO, RPO, and Division) will be allowed to submit 1 project per cycle without an Express Design that is subject to the requirement.

- This is not an additional Prioritization submittal slot
- Organizations would need to inform the SPOT Office during the submittal window if they intend
 to utilize this provision and what the project would be
 - For example, if an organization were to submit a project in P9 without an Express
 Design, they would need to inform the SPOT Office of the project details before the end
 of the P9 submittal window
- Feasibility Studies Unit will work during the submittal and scoring windows to complete Express
 Designs for projects submitted under this provision, so that cost and scope can be used in the
 current Prioritization cycle

**For P9 ONLY: the number of project submittals without an Express Design will be limited to an organization's P9 submittal allotment minus their number of allocated Express Designs between P8 and P9.

Coordination with NCDOT Feasibility Studies Unit:

NCDOT's Feasibility Studies Unit (FSU) is responsible for administering Express Designs and the overall project scoping process for NCDOT. FSU will focus a majority of their project scoping efforts on Prioritization projects. FSU anticipates that their group, with the assistance of consultants, will be able to complete 200 Express Designs for Prioritization per year, meaning FSU is committed to completing 400 Express Designs prior to the P9 submittal window close in 2027. Through streamlining efforts, this number could increase at a future date.

Submitting an Express Design Request:

Express Design requests will be managed through the Smartsheet platform. Each Planning Organization and NCDOT Division will have their own Smartsheet page where they can enter all projects that could possibly require Express Design. If there are more projects in the Smartsheet page than there are Express Design request allotments for an organization, FSU will coordinate with the requesting organization on which projects to pursue for the next cycle of Prioritization. This will be an ongoing collaborative process with FSU and the requestor. NCDOT does not require TAC approval for Express Design requests; however, each Planning Organization may seek TAC approval if desired.


Express Design Request Deadlines for P9:

Planning Organizations and NCDOT Divisions are encouraged to submit their Express Design requests as soon as they are confirmed within the organization. In order to ensure that all 400 Express Designs are complete prior to the close of the P9 submittal window, FSU will need a constant queue of projects under development.



To ensure that FSU remains on schedule, the following deadlines have been set for the P9 process:

- End of November 2025 (after P8 submittal window closes): 1/3 of Express Design requests due
- End of May 2026 (prior to Regional Impact Local Input Point assignment window): 1/3 of Express Design requests due
- End of September 2026 (between Local Input Point assignment windows): 1/3 of Express Design requests due



Express Design Allotment Per Planning Organization and NCDOT Division:

The allotments for Express Design requests for P9 were developed using the following methodology:

- 80% of the available Express Design requests (320) are designated to Planning Organizations
- 20% of the available Express Design requests (80) are designated to NCDOT Divisions
- Planning Organizations are each allotted a number of Express Design requests proportional to their P8 submittal allotments
- NCDOT Divisions are each allotted an equal share of Express Design requests
- Standard rounding is applied to all calculations, resulting in a total of 404 Express Design requests across all organizations

Updating Completed Express Designs or Cost Verification Memos:

To reduce the risk for overprogramming, NCDOT requires that a cost estimate is updated every two years, with the following conditions:

- Cost Updates do not count towards Express Design allocations
- Cost Updates are for projects where the preferred design is not materially changed
- Projects with a new functional design would require a new Express Design that would count toward the allocation
- Cost update requests should be made by utilizing the Smartsheet platform
- For P9, requests for Cost Updates should be requested by June 30, 2027

Express Designs Not Completed through Feasibility Studies Unit:

Express Designs may be completed by others, under the following conditions:

- They follow the process laid out in the Feasibility Studies Unit's current Express Design Guidance
 - Note that Feasibility Studies Unit is working with partners to update this guidance (at the time of this documentation)
- They are reviewed by the Feasibility Studies Unit to ensure they follow the NCDOT process
 - Review will focus solely on process and not outcome
